4. Your offer is to remain valid for a minimum period of 90 days from the date of Bid opening. Earnest money deposit **Rs.30,000/- (Rupees Thirty Thousand only)** shall be paid in favour of the Principal, Sainik School, Gopalganj in the form of an Account Payee Demand Draft payable at State Bank of India, Sainik School, Gopalganj Narainia, Mirganj, Branch (Code No.9212).

PART I – GENERAL INFORMATION

Sealed tenders are invited for **SUPPLY OF FRESH VEGETABLES & FRESH FRUITS** to Sainik School, Gopalganj (Bihar). Firms fulfilling the conditions and capable to undertake above supplies may submit bid form with the requisite documents such as Earnest Money Deposit, Service Tax Registration Certificate etc. Tender is to be kept in sealed cover super scribing **TENDER FOR SUPPLY OF FRESH VEGETABLES & FRESH FRUITS TO SAINIK SCHOOL GOPALGANJ**".

1. **Last date and time for depositing the Bids.** The last date for depositing of Tender will be on **10 Jan 2019 at 1615 hrs.** The sealed Tenders should be deposited / reach by the due date and time. The responsibility to ensure this lies with the Bidder.
2. **Manner of depositing the Bids.** Sealed Bids should be either dropped in the Tender Box at the school or sent by registered post at the address given above so as to reach by the due date and time. When a Tender is sent by post, this cover will be enclosed in a second strong cover. The outer cover will not bear any indication of the contents. It may be noted that quotation submitted without sealed cover may be summarily rejected. Late tenders will not be considered. No responsibility will be taken for postal delay or non-delivery/non-receipt of Bid documents. Bids sent by FAX or e-mail will not be considered.
3. **Time and date for opening of Bids.** Bids will be opened on **11 Jan 2019 at 1000hrs** and analysed by a board of Officers suitably nominated. If due to any exigency, the due date for opening of the Bids is declared a closed holiday, the Bids will be opened on the next working day at the same time or on any other day/time, as intimated by the Buyer.
4. **Location of the Tender Box.** The tender box will be located at Adm Officer of Sainik School, Gopalganj. Only those Bids that are found in the tender box will be opened.
5. **Place of opening of the Bids.** Tenders will be opened in the Conference Hall at Sainik School, Gopalganj. The Bidders may depute their representatives, duly authorized in writing, to attend the opening of Bids on the due date and time. Rates and important commercial/technical clauses quoted by all Bidders will be read out in the presence of the representatives of all the Bidders. This event will not be postponed due to non-presence of your representative.
6. **Forwarding of Bids.** Bids should be forwarded by Bidders under their original memo / letter pad inter alia furnishing details like TIN number, GST number, Bank address with NEFT Account if applicable, etc and complete postal & e-mail address of their office.

7. **Clarification regarding contents of the RFP.** A prospective bidder who requires clarification regarding the contents of the bidding documents shall notify to the Buyer in writing about the clarifications sought not later than 14 (fourteen) days prior to the date of opening of the Bids. Copies of the query and clarification by the purchaser will be sent to all prospective bidders who have received the bidding documents.
8. **Modification and Withdrawal of Bids.** A bidder may modify or withdraw his bid after submission provided that the written notice of modification or withdrawal is received by the Buyer prior to deadline prescribed for submission of bids. A withdrawal notice may be sent by fax but it should be followed by a signed confirmation copy to be sent by post and such signed confirmation should reach the purchaser not later than the deadline for submission of bids. No bid shall be modified after the deadline for submission of bids. No bid may be withdrawn in the interval between the deadline for submission of bids and expiration of the period of bid validity specified. Withdrawal of a bid during this period will result in Bidder's forfeiture of bid security.
9. **Clarification regarding contents of the Bids.** During evaluation and comparison of bids, the Buyer may, at its discretion, ask the bidder for clarification of his bid. The request for clarification will be given in writing and no change in prices or substance of the bid will be sought, offered or permitted. No post-bid clarification on the initiative of the bidder will be entertained.
10. **Rejection of Bids.** Canvassing by the Bidder in any form, unsolicited letter and post-tender correction may invoke summary rejection with forfeiture of EMD. Conditional tenders will be rejected.
11. **Unwillingness to quote.** Bidders unwilling to quote should ensure that intimation to this effect reaches before the due date and time of opening of the Bid, failing which the defaulting Bidder may be delisted for the given range of items as mentioned in this RFP.
12. **Validity of Bids.** The Bids should remain valid for a period of 90 days from the last date of submission of the Bids.
13. **Earnest Money Deposit.** Bidders are required to submit Earnest Money Deposit (EMD) for an amount of **Rs.30,000/- (Rupees Thirty Thousand only)** along with their bids. Earnest Money Deposit shall be paid in favour of the Principal, Sainik School, Gopalganj in the form of an Account Payee Demand Draft payable at State Bank of India, Sainik School, Gopalganj Narainia, Mirganj, Branch (Code No.9212). EMD of the unsuccessful bidders will be returned to them at the earliest after expiry of the final bid validity and latest on or before the 30th day after the award of the contract. The Bid Security of the successful bidder would be returned, without any interest whatsoever, after the receipt of Performance Security from them as called for in the contract. EMD is not required to be submitted by those Bidders who are registered with the Central Purchase Organization (e.g. DGS&D), National Small Industries Corporation (NSIC). The EMD will be forfeited if the bidder withdraws or amends, impairs or derogates from the tender in any respect within the validity period of their tender.

14. **Cost of tender documents.** Rs 300/-.
15. **Standard conditions of Contract (SCOC).** The bidder is required to accept our standard conditions of contract. In addition standard clauses regarding agents/agency commission, penalty for use of undue influence, access to books of account, non-disclosure of contract documents, arbitration and laws would be incorporated in the contract. Failure to do so may result in rejection of the bid submitted by the bidder.
16. **Submission of Quotes.** Firms are requested to submit quotes on comprehensive basis with requisite technical, financial and statutory specification on scope of work during the contract whilst meeting specified parameters on original letter pad with TIN/PAN/GST/Registration number of firm.
17. **Past Experience.** Past experience if any, in providing contract to major organizations including Educational institutions is to be substantiated with a certificate issued by the organization.
18. **Contact Person.** Telephone / Cell /FAX numbers are to be clearly endorsed in the application along with the particulars of the Proprietor and Authorised Person to be contacted for official correspondence.
19. **Parallel Contract.** The contract concluding authority reserves the right to distribute /apportionment of total requirement between the firms in case it is considered that L1 is not able to meet requirement in full with the same terms and conditions and at L1 rate.
20. The Principal, Sainik School, Gopalganj shall have the right to accept or reject tender bids without assigning any reason.

Note : (b) The contract will remain in sleep mode from May 2019 to Jun 2019 (for 50 days) and Oct 2019 to Nov 2019 (for 20 days) due to summer and winter vacation respectively of school and children not present in school.

2. Technical Details: As mentioned above Para 1 of Part II.

Requirement of training/on-job training

Training is required to be given by the contractor to the staff of the school on the operation of the operation of Item / system.

Requirement of installation/commissioning

Installation / commissioning is required to be done within a stipulated time.

Requirement of Technical documentation

All the technical documentation is required to be submitted by the contractor to the school.

Nature of assistance required after completion of warranty

The contractor shall specify the nature of assistance required after completion of warranty.

Requirement of pre-site/equipment inspection

Pre-site /equipment inspection will be carried out.

3. **Single Bid System** - In respect of one bid system, Bidders are required to furnish clause by clause compliance of specifications bringing out clearly the deviations from specification, if any.

4. **Delivery Period**. Delivery period for supply of items would be as per the supply order issued from time to time from the effective date of contract and the penalty will be levied at 0.5% of the order value for each day of delay. Extension of contracted delivery period will be at the sole discretion of the Buyer, with applicability of LD clause.

5. **Stage Payment Terms**. The payment should be made on receipt of 100% delivery of the items as per supply order at site and inspection. No advance payment will be made by the school. All the invoices / bills shall be supported by necessary documents and submitted in duplicate for the certification of authorized official of the unit/firm. The rates are inclusive of all taxes, transportation, packing charges etc. Nothing shall be paid over and above these unit rates and shall remain firm.

6. **Performance Bank Guarantee**. You are required to furnish 10% of the order value in the form of Bank Guarantee obtained from Nationalised /Scheduled Bank towards Performance Security. The Bank Guarantee shall remain valid for a period of 60 days beyond the date of completion of all the contractual obligations of supply, installation and commissioning of the said item.

7. **Warranty**. One year warranty for the item/System and a warranty certificate should also be provided, if fails to provide warranty services during the warranty period, the costs for making good of the equipment shall be recovered from the performance security, if applicable.

PART III – STANDARD CONDITIONS OF RFP

The Bidder is required to give confirmation of their acceptance of the Standard Conditions of the Request for Proposal mentioned below which will automatically be considered as part of the Contract concluded with the successful Bidder as selected by the User. Failure to do so may result in rejection of the Bid submitted by the Bidder.

1. **Law:** The Contract shall be considered and made in accordance with the laws of the Republic of India. The contract shall be governed by and interpreted in accordance with the laws of the Republic of India.

2. **Effective Date of the Contract:** The contract shall come into effect on the date of signatures of both the parties on the contract (**Effective Date**) and shall remain valid for 12 months / until the completion of the obligations of the parties under the contract. The services and performance of the contract agency shall commence from the effective date of the contract.

3. **Arbitration:** All disputes or differences arising out of or in connection with the Contract shall be settled by bilateral discussions. Any dispute, disagreement or question arising out of or relating to the Contract or relating to construction or performance, which cannot be settled amicably, may be resolved through arbitration.

4. **Penalty for use of Undue influence:** The Firm / Agency undertakes that it has not given, offered or promised to give, directly or indirectly, any gift, consideration, reward, commission, fees, brokerage or inducement to any person in service of the User or otherwise in obtaining the Contracts or forbearing to do or for having done or forborne to do any act in relation to the obtaining or executing of the present Contract or any other Contract with the Government of India for showing or forbearing to show favour or disfavour to any person in relation to the present Contract or any other Contract with the Government of India. Any breach of the aforesaid undertaking by the firm / agency or any one employed by it or acting on its behalf (whether with or without the knowledge of the said firm / agency) or the commission of any offence by the bidder or anyone employed by him or acting on his behalf, as defined in Chapter IX of the Indian Penal Code, 1860 or the Prevention of Corruption Act, 1986 or any other Act enacted for the prevention of corruption shall entitle the User to cancel the contract and all or any other contracts with the bidder / bidders and recover from the bidder the amount of any loss arising from such cancellation. A decision of the User or his nominee to the effect that breach of the undertaking had been committed shall be final and binding on the bidder (s). Giving or offering of any gift, bribe or inducement or any attempt at any such act on behalf of the bidder towards any officer/employee of the User or to any other person in a position to influence any officer/employee of the User for showing any favour in relation to this or any other contract, shall render the bidder to such liability / penalty as the User may deem proper, including but not limited to termination of the contract, imposition of penal damages, forfeiture of the Bank Guarantee and refund of the amounts paid by the User.

5. **Agents / Agency Commission.** The bidder confirms and declares to the User that the bidder is the original provider of the services referred to in this Contract and has

not engaged any individual or firm, whether Indian or foreign whatsoever, to intercede, facilitate or in any way to recommend to the Government of India or any of its functionaries, whether officially or unofficially, to the award of the contract to the bidder; nor has any amount been paid, promised or intended to be paid to any such individual or firm in respect of any such intercession, facilitation or recommendation. The bidder agrees that if it is established at any time to the satisfaction of the User that the present declaration is in any way incorrect or if at a later stage it is discovered by the User that the bidder has engaged any such individual/firm, and paid or intended to pay an amount, gift, reward, fees, commission or consideration to such person, party, firm or institution, whether before or after the signing of this contract, the bidder will be liable to refund that amount to the User. The bidder will also be debarred from entering into any Services Contract with the Government of India for a minimum period of five years. The User will also have a right to consider cancellation of the Contract either wholly or in part, without any entitlement or compensation to the bidder who shall in such an event be liable to refund all payments made by the User in terms of the Contract along with interest at the rate of 2% per annum above LIBOR rate. The User will also have the right to recover any such amount from any contracts concluded earlier with GOI.

6. Access to Books of Accounts. In case it is found to the satisfaction of the User that the Bidder has engaged an Agent or Paid commission or influenced any person to obtain the contract as described in clauses relating to Agents/Agency Commission and penalty for use of undue influence, the Bidder, on a specific request of the User, shall provide necessary information/inspection of the relevant financial documents/information.

7. Non-disclosure of Contract documents. Except with the written consent of the User / Bidder, other party shall not disclose the contract or any provision, specification, or information thereof to any third party.

8. Liquidated Damages. In the event of the contractor's failure to submit the Bonds, Guarantees and Documents, supply the stores/goods and conduct trials, installation of equipment, training etc as specified in this Supply / Work Order, Buyer may, at this discretion, withhold any payment until the completion of the Supply / Work Order. The Buyer may also deduct from the Seller as agreed, Liquidated Damages to the sum of 0.5% of the Supply Order price of the delayed/undelivered stores/services mentioned above for every week of delay or part of a week, subject to the maximum value of the Liquidated Damages being not higher than 10% of the value of delayed stores.

9. Liability for Damage. If the contractor or employees shall injure or destroy any part of the Govt property in which they may be working or if any damage shall happen to the work while in progress the contractor shall upon receipt of a notice in writing in that behalf make the same good at his own expense.

10. Quality Management. The contractor shall attend to any complaints received in connection with the services immediately. Any failure will attract penalty.

11. Inspection / Audit of the Services. Periodic quality inspection will be carried out by Contract Operating Authority to ensure the set standard are in practice. Similarly

Service providers are to carry out their routine inspections to ensure the set standards are in practice. The customer feedback (complaints or request) would be dealt immediately up to the set standards and satisfaction of the customer. Corrective action plan to be made on each customer feedback report to ensure similar complaints does not exist in future.

12. Termination of Contract. The User shall have the right to terminate this Contract in part or in full in any of the following cases:-

- (a) The services provided are delayed for causes not attributable to **Force Majeure for more than one month after** commencement of the said services.
- (b) The Bidder is declared **bankrupt or becomes insolvent.**
- (c) The User has noticed that the Bidder has utilized the services of any Indian/Foreign agent in getting this contract and paid any commission to such individual/company etc.
- (d) As per **decision of the Arbitration Tribunal.**
- (e) On account of any default on part of the contractor.

13. Notices. Any notice required or permitted by the contract shall be written in the English language and may be delivered personally or may be sent by FAX or registered pre-paid mail/airmail, addressed to the last known address of the party to whom it is sent.

14. Transfer and Sub-letting. The Bidder has no right to give, bargain, sell, assign or sublet or otherwise dispose of the Contract or any part thereof, as well as to give or to let a third party take benefit or advantage of the present Contract or any part thereof.

15. Patents and other Industrial Property Rights. NOT APPLICABLE.

16. Amendments. No provision of present Contract shall be changed or modified in any way (including this provision) either in whole or in part except by an instrument in writing made after the date of this Contract and signed on behalf of both the parties and which expressly states to amend the present Contract.

17. Taxes and Duties (a) General

- (a) If Bidder desires to ask for excise duty or Sales Tax / GST extra, the same must be specifically stated. In the absence of any such stipulation, it will be presumed that the prices include all such charges and no claim for the same will be entertained.
- (b) If reimbursement of any Duty/Tax is intended as extra over the quoted prices, the Bidder must specifically say so. In the absence of any such stipulation it will be presumed that the prices quoted are firm and final and no claim on account of such duty/tax will be entreated after the opening of tenders.
- (c) If a Bidder chooses to quote a price inclusive of any duty/tax and does not confirm inclusive of such duty/tax so included is firm and final, he should clearly

indicate the rate of such duty/tax and quantum of such duty/tax included in the price. Failure to do so may result in ignoring of such offers summarily.

(d) If a Bidder is exempted from payment of any duty/tax upto any value of supplies from them, he should clearly state that no such duty/tax will be charged by him up to the limit of exemption which he may have, if any concession is available in regard to rate/quantum of any Duty/tax, it should be brought out clearly. Stipulations like, the said duty/tax was presently not applicable but the same will be charged if it becomes liveable later on, will not be accepted unless in such cases it is clearly stated by a Bidder that such duty/tax will not be charged by him even if the same becomes applicable later on. In respect of the Bidders, who fail to comply with this requirement, their quoted prices shall be loaded with the quantum of such duty/tax which is normally applicable on the item in question for the purpose of comparing their prices with other Bidders.

(e) Any change in any duty/tax upward/downward as a result of any statutory variation in excise taking place within contract terms shall be allowed to the extent of actual quantum of such duty/tax paid by the supplier. Similarly, in case of downward revision in any duty/tax, the actual quantum of reduction of such duty/tax shall be reimbursed to the Buyer by the Seller. All such adjustments shall include all reliefs, exemptions, rebates, concession etc. If any obtained by the Seller.

18. **Goods and Services Tax (GST)**

(a) GST will be paid to the Seller at the rate applicable based on description, HSN/SAC code and the relevant schedule of CGST Act.

(b) In pursuance will Section 171 (i) of CGST Act, an undertaking is to be effected by the seller declaring that “ Any reduction in rate of tax on any supply of goods or services or the benefit of input tax credit (ITC) shall be passed on to the recipient by way of commensurate reduction in prices”. Further, in case it is detected by the government that any ITC has accrued to the seller as a result of migrating to GST, after receiving the consideration / reimbursement for this supplies, the seller is mandated to refund the same accordingly to the Paying Authority, giving details and particulars of the transactions.

(c) Unless otherwise specifically agreed to in terms of the contract, the Buyer shall not be liable for any claim on account of fresh imposition and/or increase of GST on raw materials and / or components used directly in the manufacture of the contracted stores taking place during the pendency of the contract.

PART IV- SPECIAL CONDITIONS OF RFP

The Bidder is required to give confirmation of their acceptance of Special Conditions of the RFP mentioned below which will automatically be considered as part of the contract concluded with the successful bidder (i.e Bidder in the Contract) as selected by the User. Failure to do so may result in rejection of Bid submitted by the Bidder.

1. **Delivery Period.** Supplies will be made in time and date stipulated without causing any delay. Please note that Contract can be cancelled unilaterally by the Buyer in case items are not received within the contracted delivery period. Extension of contracted delivery period will be at the sole discretion of the Buyer, with applicability of LD clause.
2. **Stage Payment Terms.**
 - (a) All payments will be made to the contractor on fortnightly basis after deducting the income tax as per Govt rules.
 - (b) The rates are inclusive of all taxes, transportation, packing charges etc. Nothing shall be paid over and above these unit rates and shall remain firm.
3. **Security Deposit:** Successful bidder is required to deposit a Demand Draft of **Rs.1,00,000/- (Rupees One Lakh only)** obtained in favour of the Principal, Sainik School Gopalganj from any Nationalised / Scheduled Bank towards Performance Security for 12 months + 60 days. 6. Fall clause. The following fall clause will form part of the contract placed on successful bidder.

(a) The price charged for the service provided under the contract by the contractor shall in no event exceed the lowest prices at high the Bidder bids the services or offer to provide services of identical description to any persons/ organization including the User or any department of the central government or any department of state government or any statutory undertaking the central or state government as the case may be during the period till performance of all contracts placed during the currency o the rate contract is completed.

PART V – EVALUATION CRITERIA & PRICE BID ISSUES

1. Evaluation Criteria. The broad guidelines for evaluation of bids will be as follows:

(a) Only those Bids will be evaluated which are found to be fulfilling all the eligibility and qualifying requirements of the RFP, both technically and commercially.

(b) The Lowest Bid will be decided upon the lowest price quoted by the particular Bidder as per the Price format given at enclosure 1. The consideration of taxes and duties in evaluation process will be as follows.

(c) In cases where only indigenous Bidders are competing, all taxes and duties (including those for which exemption certificate are issued) quoted by the Bidders will be considered. The ultimate cost to the Buyer would be the deciding factor for ranking of Bids.

(d) The bidders are required to spell out the rates of customs duty, excise duty, GST, Service Tax, etc in unambiguous terms; otherwise their offers will be loaded with the maximum rates of duties and taxes for the purpose of comparison of prices. If reimbursement of Customs duty / excise Duty / GST is intended a extra, over the quoted prices, the Bidder must specifically say so. In the absence of any such stipulation it will be presumed that the prices quoted are firm and final and no claim on account of such duties will be entrained after the opening of tenderers. If a Bidder chooses to quote a price inclusive of any duty and does not confirm inclusive of such duty so included is firm and final, he should clearly indicate the rate of such duty and quantum of excise duty included in the price. Failure to do so may result in ignoring of such offers summarily. If a Bidder is exempted from payment of Customs duty/Excise Duty/GST duty upto any value of supplies from them, they should clearly state that no excise duty will be charged by them upto the limit of exemption which they may have. If any concession is available in regard to rate/quantum of customs duty / Excise duty / GST it should be brought out clearly. Stipulations like, excise duty was presently not applicable but the same will be charged if it becomes leviable later on, will not be accepted unless in such cases it is clearly stated by a bidder that excise duty will not be charged by him even if the same becomes applicable later on. In respect of the Bidders who fail to comply with this requirement, heir quoted prices shall be loaded with the quantum of excise duty which is normally applicable on the item in question for the purpose of comparing their prices with the Bidders. 5. Quality

(a) POTATO

(i) The Potato fresh will be the one from the crop in season and freshly dug. These will be of similar variety characteristics, washed well and graded uniformly for size for individual supplies. Fresh potatoes will be of average size so that they should not pass through a circular sieve having aperture of 3 cms x 3 cms and should not retain on a circular sieve having aperture of 10 cms x 10 cms.

(ii) The fresh potato will be sound, wholesom and at proper stage of maturity, with round (flat) or pebble round (spherical), pear shaped, long oval, short oval or oval shapes and must be free from mal formed and spindle shape tubers.

(iii) Fresh potato will be in a pronounced state of rest, free from signs of sprouting, injury, cuts, bruises, shrinkage, physiological disorders, insect damage, diseases and any type of discoloration.

(b) ONIONS

(i) An appropriate variety of the season will be accepted for supply. The onion will be mature, reasonably firm viz not tangible soft or sponge.

(ii) Onion bulbs will be dry, well formed and give a rustling noise when handled. They will be well cured with tough clinging skins and close necks. Tops when present shall not exceed 2 cms in length and such onions will not constitute more than 20% by weight of supply.

(iii) Damaged onions or the onion bulbs, the appearance or the edible or marketing quality of which is materially affected by splitting, dry sun scaled, sunburn, staining, sprouting, seed stems or mechanical injuries.

(iv) Fresh onions will be of average size so that they should not pass through a circular sieve having aperture of 3 cms x 3 cms.

(c) FRESH VEGETABLES

(i) The fresh vegetables will be crisp, well formed of proper tender maturity and will not be with coarse fibers, stringy, old or hard due to over age and over growth, spongy or fluffy due to age. The vegetables shall be those in season commencing from early season arrivals and also late season receipts. These will be freshly gathered cleaned, graded for soundness and wholesomeness.

(ii) The vegetable fresh will be free from insect infestation, physiological disorders, blemishes or damage and disease. They will also be free from discoloration, injury damage or signs or improper storage, handling and transportation, which renders them a poor look as to the freshness.

- (iii) The vegetables can broadly be classified into
- (aa) Root varieties
 - (ab) Creeper varieties
 - (ac) Leafy varieties
 - (ad) Fruits/surface/overground varieties

(d) **FRESH FRUITS**

(i) The fresh fruit will be of good average size, ripe, sound wholesome, juicy, well formed and matured. The fruit fresh will be free from insect infestation, blemishes or damage by diseases or any other injuries to health contaminants. It will also be free from discoloration, injury, damage, or signs of improper storage, handling and transportation rendering poor organoleptic appeal to the fruit. The fruit fresh stored in cold storage may also be accepted provided the supplies possess the above qualitative requirements and have not undergone any physiological damage or ripening, staleness due to low temperature treatments. Such supply will also be free from free burns and will be properly thawed.

(e) The rates are quoted including all taxes, transport and delivery at Sainik School, Gopalganj, Post Hathuwa, Dist Gopalganj.

1. The contract will be valid for the period commencing from “**15 Jan 2019 to 31 Jan 2020 (for SUPPLY OF FRESH VEGETABLES & FRESH FRUITS)** from the date of commencement of Agreement. If required the period of contract can be extended at the same rates to a maximum of three months duration by Adm Officer, Sainik School Gopalganj.
 - (a) The contractor shall deliver the supplies/services at their expense in such time and place to such representative and at the Ration Stand or at any other specified place within the school premises as per the specifications at the rates given in the schedule attached to this contract.
 - (b) The Adm Officer, Sainik School Gopalganj may authorize such officer/officers as he may wish to operate the contract on his behalf and the contractor and his agents will accept and carry out instructions given by the officer (or his representatives) in connection with the contract as if those were issued by the Adm Officer, Sainik School Gopalganj.
 - (c) The Adm Officer, Sainik School Gopalganj or his authorized representative to whom the supplies/services are to be delivered in the contract may reject the supplies/services in whole or in part, if the supplies are not in accordance with the contract agreement in their opinion.
 - (d) The contractor shall not charge or be paid for such supplies/services rejected as above and such supplies/services shall be replaced by him at once at his expense.
 - (e) The contractor shall neither claim nor be entitled to payment for any damage that rejected supplies may suffer from cutting, tearing or any other harm incidental to a full examination and test of such supplies/services.

15. By virtue of the contractor' position as a contractor he fully understands that he and his employees and representatives are not to divulge any information in respect of this school that may come to their knowledge regarding strength, composition, location or rates of supply etc., to any unauthorized persons/persons.
16. The contractor acknowledges that he has made himself fully acquainted with all the conditions and circumstances under which the services required under this contract will have to be made or furnished and with all the terms, clauses, conditions, specifications and other detail of the contract and he shall not plead ignorance of any of these as an excuse in case of complaints against or rejection of services, tendered by him or with a view whether to ask for enhancement of any rates agreed to in the contract or to evade any of the obligation under the contract.
17. All questions relating to the execution of the terms of the agreement and all disputes and differences which shall arise during the progress of work under this agreement or any other matter arising out of or relating to this agreement on the work to be done, or payment or with regard to construction, meaning and affect of this agreement or any part thereof shall be referred to the sole arbitration of the **Principal, Sainik School Gopalganj** whose decision shall be final conclusive and binding upon the parties at the agreement.

24. Principal, Sainik School Gopalganj is empowered to suspend any type or all types of business with the tenderer or with any of or all of its partners for a duration of one year.
- (a) If the contractor assigns or sublets this contract without the Adm Officer's written approval or if the contractor attempted to do so.
 - (b) If the contractor or any of his agents or his servants are guilty of fraud in respect of the contract, directly or indirectly give or promise to give or offer any bribe, fit, loan, reward or advantage, pecuniary or otherwise to any officer or persons in employment of the school.
 - (c) If the contractor declines, neglects or delays to comply with any demand or requisition or in any other way fails to perform or serve any condition of the contract.
 - (d) If the contractor resorts to illegal or immoral practices during the course of execution of the contract agreement.
 - (e) If the contractor resorts to lending money to any of the staff members or to any person within the campus.
 - (f) If in the larger interest of Sainik School Gopalganj the continuation of the contractor is undesirable and unwarranted.
25. The successful tenderer will execute an agreement in favour of Adm Officer, Sainik School Gopalganj on court fee non judicial stamp of appropriate denomination incorporating the above and such other terms and may be prescribed by Adm Officer, Sainik School Gopalganj. Income tax deductions will be made as per Govt. rules from the contractor's bills.
